Joining the opt-out provisions adopted with CONSOB Resolution no. 18079 dated 20 January 2012

In accordance with art. 3 of CONSOB Resolution no. 18079 of 20 January 2012, DADA S.p.A. has chosen to join the process of regulatory simplification pursuant to art. 70, paragraph 8, and art. 71, paragraph 1-bis of the Regulation adopted by CONSOB with Resolution 11971 of 14 May 1999, as subsequently amended and supplemented (CONSOB Issuer Regulation). It therefore chooses the option to derogate from the requirement to publish information documents as required in Attachment 3B of the above-mentioned CONSOB Regulation for significant transactions such as mergers, spin-offs, capital increases in kind, acquisitions and disposals.
